MESSAGE FROM THE ORGANIZING CHAIRMAN


National Renal Registry (NRR) manages several important national databases related to dialysis and renal transplantation. The Malaysian Dialysis and Transplant Registry (MDTR) is in its 23rd year of operation whilst its sister registry, The Malaysian Registry of Renal Biopsy (MRRB) is preparing for its 6th report. From the large MDTR database, a national waiting list for patients needing deceased donor kidney transplant is maintained in the electronic Malaysian Organ Sharing System (eMOSS) database.

Traditionally, NRR had a meet the SDPs session during the Annual Congress in Nephrology hosted by the Malaysian Society of Nephrology. As MSN hosted the ISHD Congress in September this year; the NRR has to organize this one day seminar to report the latest MDTR findings for the year of 2014.


With increasing role played by the NGOs and private sectors in the provision of haemodialysis in this country, NRR is aware of several issues that keep cropping up related to the funding of haemodialysis treatment and the regulatory issues related to HD unit licensing and monitoring by the Ministry of Health which require further clarification. A dialogue session to meet the funding providers (JPA & SOCSO) and regulators (Medical Practice Division) will be held to allow access to information and enable outstanding issues to be sorted out.

It is also our wish that the program lined up for this one day seminar will assist us in providing better and safer dialysis services in this country.
